TAKEN WITH A PINCH OF SNUFF

My one and only mental picture of Eliza, my maternal great grandmother, is of a little, wizened old lady of seemingly great age, sitting upright in a hospital bed surreptitiously taking an occasional pinch of snuff, to which she was apparently very partial. How or when she acquired this habit I have no idea but her family considered it disgusting.

Apart from these brief details the only facts I knew were that she was born in Macclesfield and died around 1923 in Birmingham. She was a complete enigma. However, after leading me a merry dance for two or three years some interesting facts have emerged.

Granddad's birth certificate said – father Peter Fowler, mother Eliza Fowler formerly Lovatt. So I proceeded to look for their marriage C1876 in Macclesfield. Peter Fowler was a fairly unusual name in that period and there was only one in the relevant period at St Catherine's House.

Unfortunately there was no matching Eliza Lovatt. On my next visit I searched again, extending the period searched, in case great aunt Matilda, their first child had been a little premature. Still no luck. I then learned that Peter had died when Gt Aunt Matilda was young so I had a search done which produced Peter's death certificate, death reported by Eliza the widow. Certificates were about to go up in price so I took the plunge and bought the marriage certificate for the one and only Peter marriage. Peter had married an Eliza, but her surname was Nadin!!

I thought of several reasons why Lovatt could have cropped up on their children's birth certificates. Great grandfather could have been forgetful and when asked by the Registrar for his wife's maiden name had to be prompted by being reminded that it would be the same as his parents in law. That could mean that Mr Nadin had died and Mrs Nadin had remarried. Or perhaps GGF had been celebrating the births and was a little drunk (he was a ginger beer carter) but how do you prove that?

I followed the father's name on Eliza's marriage certificate, William Nadin, platelayer and tried to find her birth certificate. None matched. I visited Macclesfield and looked for her baptism in either name. No baptisms. I went to Chester and searched the births for the area – no luck. I wrote to several churches – nothing. I nearly gave up.

The next thought was that if Mr Nadin had died Mrs Nadin may have married a Mr Lovatt. At St Catherine's a marriage had occurred in Macclesfield in 1870 between a Mr Lovatt and a 42 year old Miss Nadin, but I didn't feel very hopeful. Then a friend and I went to Chester and she was determined to solve my problem. She did!! The Census returns for the 1861 showed an unmarried Sarah with Eliza at exactly the right age, while the 1871 Census showed the same Sarah married to Mr Lovatt with Eliza at the same address.

It then became quite easy to see how William Nadin platelayer of the marriage certificate could have occurred. William Lovatt's Christian name and occupation had been borrowed and added to Eliza's own maiden name. Her birth was found, then, quite easily, with just her mother's name and revealed that she had been born in the Union Workhouse, Macclesfield and had no father she could name.

She was only 63 when she died, so with dubious birth, a successful cover up on her marriage lines, early widowhood and young children to bring up alone, perhaps the snuff taking was not so bad after all. Author: Helen Kidd
